- Please note that Request for Proposal (RFP) shall be issued only to the shortlisted Companies who were found to be eligible based on their response to this EoI.
- NCFE reserves the right to reject any or all proposals received in response to the EoI without assigning any reasons whatsoever.
- This document does not constitute an offer, nor does this document or anything contained herein, shall form a basis of any contract or commitment whatsoever.
- The Companies shall bear all the costs incurred for preparation and submission of response to this EoI.
- The Companies are advised to submit all documents as mentioned in Section 5 strictly in the prescribed format.
- Incomplete and conditional proposals shall not be accepted.
- Submission of more than one Proposal by a company will render the proposal liable for rejection. Companies may assess the nature and quantum of the activities before submitting their proposals

7. BROAD SCOPE OF WORK AND DELIVERABLES

To engage a qualified and experienced Company having experience in the field of "Designing, Development, Implementation, Operation and Maintenance of Website". The Company shall be required to design a website for NCFE and provide support and maintenance services for a period of three years.

Broadly, the Company would be required to analyze the functional requirements of the proposed website for NCFE. Following the said analysis work the company needs to design, develop and implement the website. Furthermore, the company shall also provide operation and Maintenance services for the website. The proposed website is expected to be in English, Hindi and 11 other Indian languages i.e. Tamil, Bengali, Telugu, Malayalam, Kannada, Odia, Urdu, Gujarati, Marathi, Assamese and Punjabi.

Currently, NCFE has a website. The url of the website is <u>www.ncfe.org.in</u>. Interested companies may visit the website to have an idea about the proposed website development work.

The Website development work to be carried out by the selected company must comply with the following:

- i. The Website should be designed using HTML5 (for the front end) and other latest technologies for the backend including a Content Management System. Amongst many other features the website shall also have a comprehensive Dashboard. The details of the preferred technologies to be used shall be provided in the RFP to be issued to the eligible companies at a later point time.
- ii. Compliance with W3C guidelines.
- iii. The Company shall also get the website audited by Standardization Testing and Quality Certification (STQC) for Guidelines for Indian Government Websites GIGW compliance.
- iv. Migration of the content from the existing website to proposed new website.
- v. Training: Hands-on training to the designated staff of NCFE on the basics of website management which includes Publishing and editing the content etc.,
- vi. The proposed website is expected to be complying with security standards. The company is required to engage the services of a Cert-In certified third party.
- vii. Post implementation support and maintenance services complying with service levels as required by NCFE.
